Arthur Vail and V. S. Lawrence hereby certify that the above or foregoing Vail and Lawrence Addition to the City of Rock Springs, Wyoming, is located on that part of the Northwest quarter (NW 1/4) of section Thirty-six (36), Township Nineteen (19) North, Range One Hundred Five (105) West, particularly described as follows: -
Beginning at the southwest corner of the said North west quarter; thence East Five Hundred Ninety (590) Feet with the east and west center line of said section 36; thence North Two Hundred and Fifty feet; thence west Five Hundred and Ninety (590) feet parallel to said center line, to west line of said section 36; thence south Two hundred and fifty (250) feet with west line of said section 36, to beginning.

And that the survey and staking thereof into lots and blocks and streets and alleys as said Vail and Lawrence Addition to the city of Rock Springs, Wyoming, as appears on this plat is with the consent and in accordance with the desires of the undersigned owners and proprietors, and that they are the owners in fee simple thereof, subject to the reservations in deed of conveyance from the Central Coal and Coke Company, a Missouri Corporation, to Arthur Vail and V. S. Lawrence, May 5, 1921, and duly recorded in the County of Sweetwater, State of Wyoming, and that the foregoing is a correct plat of said Vail and Lawrence Addition, and that the dimensions of the lots and blocks, and the widths of the said streets and alleys, are correctly indicated on the plat by figures representing feet and decimals of a foot. And the said Arthur Vail and V. S. Lawrence hereby dedicate to the Public, use all streets and alleys as shown upon the foregoing plat.
