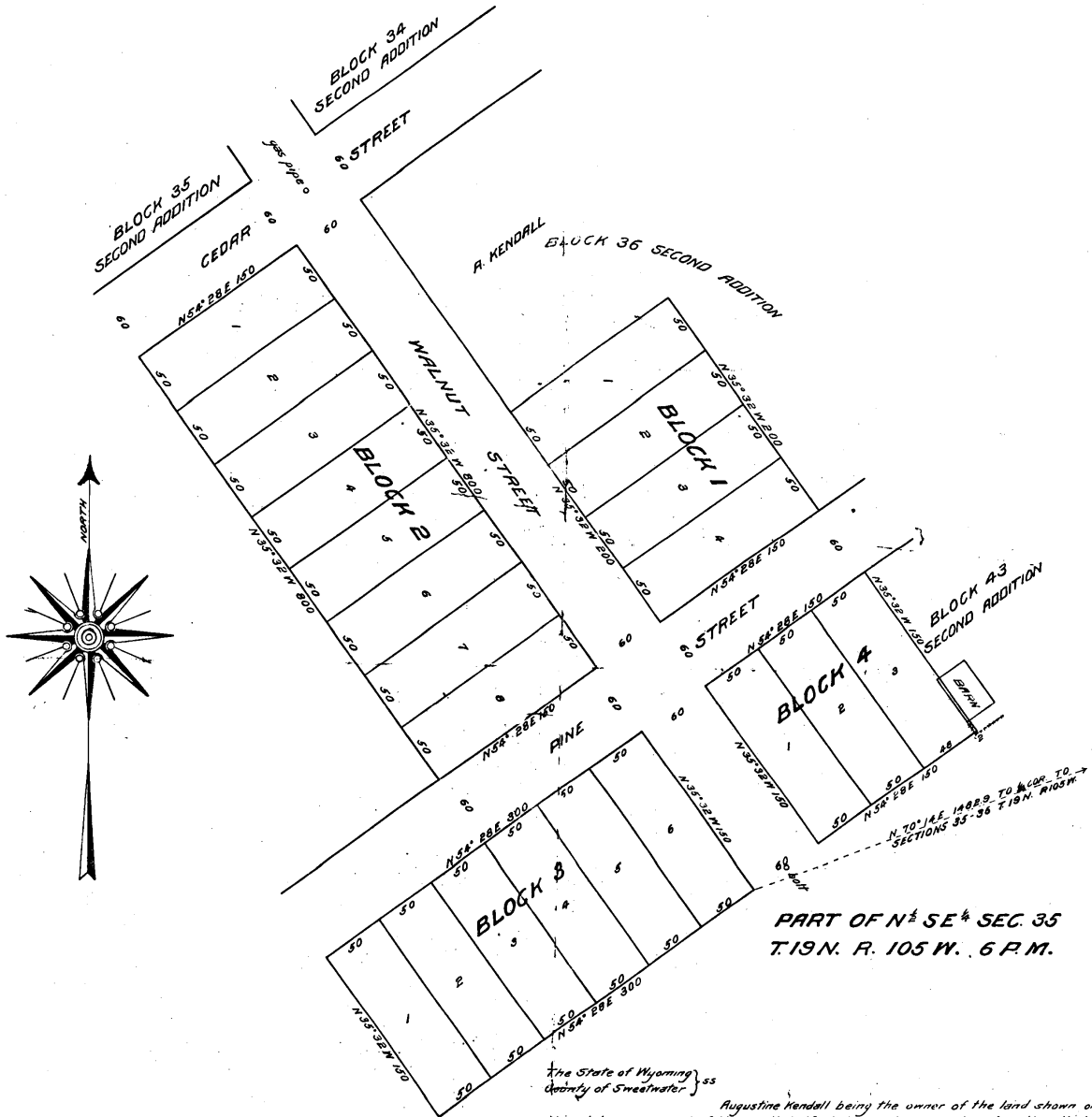


# HIGH POINT ADDITION TO ROCK SPRINGS, WYOMING.
