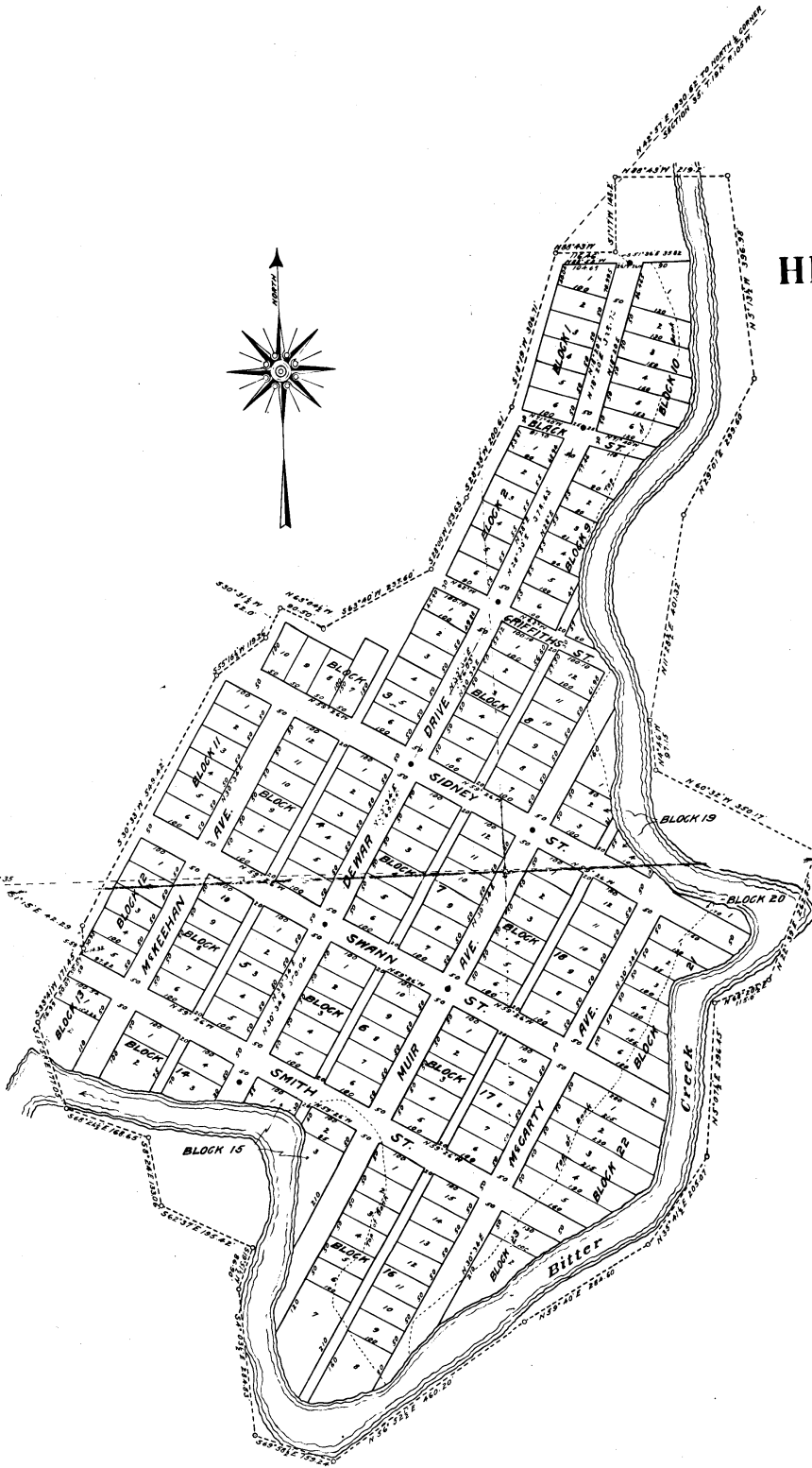
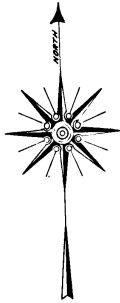


# HILLSIDE ADDITION TO ROCK SPRINGS WYOMING

KNOW ALL MEN BY THESE PRESENTS: That V. Facinelli and J. M. Cohen, hereby certify that the above or foregoing Hillside Addition to Rock Springs of the County of Sweetwater, in the State of Wyoming is located in the East 1/4 of the Southeast quarter (E 1/4 SW 1/4) of the Northwest quarter (NW 1/4) of the North half of the Southeast quarter (N 1/2 SE 1/4) of section 35 of Township 19 North of Range 105 West of the Sixth Principal Meridian, more particularly described as follows, to-wit: Beginning at a point which bears S 82° 27' 10" W 183.85 feet from the North & West corner of section 35 T. 19 N. R. 105 W. 542.57 feet from the North & West corner of section 36 T. 19 N.
